Conditions générales d'utilisation des services du CDGP Terms and conditions of use of CDGP services

The Data Center of Deep Geothermal energy (CDGP) promotes research by providing access to data on behalf of their respective owners (PROVIDER). The latter defines the distribution rules and the 'how to cite' section, information that is described in the metadata attached to the data.

In these Terms and Conditions of Use of CDGP services, "DATA" mean the data and all contents provided by the CDGP and PROVIDERS to the USER. "DATA" include all data, digital maps, text, graphics, drawings, diagrams, photographs, physical geological samples and other materials of the CDGP.

In these Terms and Conditions of Use of CDGP services, "PROJECT" refers to the research/ project of the USER. Depending on the distribution rules set by the PROVIDER, it can be asked to the USER to describe the purpose and termination date of his PROJECT before getting the approval of data access.

In consideration of the CDGP and other organizations providing the Data, by using the CDGP services, the USER accept unconditionally the Terms and Conditions of Use of CDGP services. The Terms and conditions of Use may be revised and/or amended by the CDGP administrators without prior notice.

Unless otherwise expressly set forth by the PROVIDER:

The PROVIDER grants to the USER a free, non-exclusive, right to use the DATA only for the purpose of his PROJECT.

The USER agree:

- To use the DATA made available by PROVIDER solely for the non-commercial PROJECT, not to sell results of these studies, and to safeguard the mental properties of the PROVIDER.
- To apply no changes or corrections to the DATA received, unless authorized by the PROVIDER.
- Not to divulge the DATA received, even in abstracted form, to third parties, unless specifically authorized by the PROVIDER.
- To apply with the PROVIDER for the authorization to publish research results that are based on the study of the DATA made available to him. Such an application must include a manuscript copy of the intended publication.
- Upon receipt of the publication authorization, to acknowledge in the corresponding publication or report the ownership of the DATA used and the permission to publish.
- To provide the PROVIDER free of charge with a copy of the corresponding paper or report.
- After completion of the PROJECT, to either erase or return the DATA to the PROVIDER.

In-the-framework-of the CDGP LabEx G-Eau-Thermie Profonde Project, the requested DATA-will-be made available free of charge to the USER under the condition that use of the subject DATA is restricted to the above described PROJECT.

Should mobilization of the requested DATA involve an above normal effort by the PROVIDER (e.g. reproduction costs), he will inform the USER accordingly, and following the latter's consent, will charge him with the corresponding costs.

The right to use the DATA made available expires with the termination date of the subject PROJECT when applicable.

Use of data

1 - Personal data

The information collected by CDGP during the registration service are subject to a treatment designed to provide the best service to users and will provide access to personalized features of CDGP systems and partners systems.

The information are collected:

To make statistics on the use of data and anonymized reports will be produced on these uses in their context

To make individualized user support.

Personal data can be stored and transferred to PROVIDERS to enable them to use these data in accordance with these rules.

CDGP does not communicate and does not sell the personal data to third parties other than the aforementioned partners.

2 - Navigation data Use of Cookies
